#### **Finance Committee Report:**

Hoff reported on the Finance Committee Meeting held on May 22, 2025.

- 1. Expenditures for April 24 May 21, 2025, totaling \$17,395.19.
- 2. Profit and Loss Budget vs Actual is 39.3%.
- 3. Balance Sheet as of May 21, 2025, is \$580,210.87.

### Appearance:

The Board was joined by Jennifer Cady and Josh Skelton to discuss the Allete/Minnesota Power acquisition. The acquisition aims to strengthen the operational and financial foundation of Minnesota Power while enhancing its commitment to providing reliable, affordable, and sustainable energy solutions to customers. Minnesota Power will remain headquartered in Duluth and is expected to hit 90% renewable energy by 2035.

#### **New Business:**

- The Board met with three nominees for the vacant Board seat. Each nominee (Rick Blake, Brandi Lautigar, Steve Biondich) spoke to the Board for 4 minutes. By a show of hands, Steve Biondich led the votes and accepted the seat with a term ending 12/31/25.
- A motion to approve the RAMS Executive Director Job Description was made by Fisher and supported by Holewa. Motion carried.
- A motion to approve the new Executive Director Evalution Process was made by Hoff and supported by Grose. Motion carried.
- Executive Director Peltier will work with Jeff Anderson to pick a date for the Summer Membership Meeting with the goal that Legislators will be able to attend.
- Jeff Anderson gave an update on the Legislature:
  - The session ended on Monday, May 19, with no big bills passed
  - Still left unresolved: taxes, jobs and labor, health and human services, finance, transportation, education
  - Bills that have been passed: Agriculture, broadband, vets, cannabis, human services policy, legacy
  - ❖ A Special Session won't be called until everything has been settled. It will likely be 2-3 days long. If the budget is not passed by June 1, layoff notices will go out to state employees, with a layoff starting July 1.
