Finance Committee Report:

Hoff reported on the Finance Committee Meeting held on November 20, 2025.

1. Expenditures for October 23 – November 19, 2025, totaling \$14,101.17.
2. Profit and Loss Budget vs Actual is 81%.
3. Balance Sheet as of November 20, 2025, is \$606,976.41.

New Business:

- A motion to approve the employee performance review of the Administrative Assistant was made by Pittman and supported by Davis. Motion carried
- A motion to approve the employment agreement for RAMS Administrative Assistant was made by Stolp and supported by Pittman. Motion carried.
- A motion to approve a letter of support for Mike Jugovich's application for LCCMR was made by Holewa and supported by Loeffler. Motion carried.
- A motion to approve a letter to DNR requesting clarification on the process for member mining royalty revenue disbursements was made by Rahja and supported by Biondich. Motion carried.
- A motion to approve a letter to MPCA requesting update on economic impact and considerations of the sulfate standard raised by RAMS and member comment, call for criteria used for enrolling/disenrolling wild rice waterbodies was made by Holewa and supported by Pittman. Motion carried.
- A motion to approve a letter of support for Mesabi Metallica Permit to Mine was made by Stolp and supported by Davis. Motion carried.
- Executive Director Peltier gave an update on the Permanent School Fund. The task force will make a recommendation to the Legislature on or before January 15, 2026.
- Executive Director Peltier went over the results of the Legislative Priorities Survey that went out to Members. Thirty Members responded: 13 schools, 11 cities, and 6 townships.
- A motion to approve an additional expenditure of up to \$5,000 (1/3 of the total cost) for an updated report on costs of sulfate treatment for municipal wastewater treatment facilities was made by Davis and supported by Rahja. Motion carried.
